DURING THE ACCREDITATION IN DUISBURG

1. Verification of Proof of Health Insurance Coverage

During the accreditation, every participant will be requested to present his or her proof of health insurance coverage. Insurance agency experts will be present to verify that the participant's health insurance coverage meets acceptable standards. Please make sure that every participant brings proof of his or her health insurance coverage. If no proof is available, or if the experts should consider the coverage insufficient, the participant must agree to pay for short-term health insurance coverage on site, at a cost of €15-20 for the duration of the event.

2. Consent to Privacy Policy

In accordance with German law, every participant, in order to be accredited, must sign that he or she agrees with the electronic registration and processing of his or her personal data. After the 2005 World Games, the Duisburg Organizing Committee (DOC) must by law delete the data.

3. Anti-Doping Declaration

Every participant, in order to be accredited, must sign that he or she agrees to be bound by the anti-doping rules of the World Anti-Doping Agency (WADA) and the International World Games Association (IWGA).

4. Photographic Rights

Every participant, in order to be accredited, must grant to the IWGA/DOC the right to use his or her photographic likeness to promote the 2005 World Games.

DECLARATION

**To be signed by each participant*

I, the undersigned, as a participant in The World Games 2005, hereby acknowledge and agree as follows:

1. I have received information on the IWGA Anti Doping Rules and was given the prior opportunity to review the IWGA Anti-Doping Rules.
2. I consent and agree to comply with and be bound by all of the provisions and conditions of the WADA Anti-Doping Code, the IWGA Anti-Doping Rules and Anti-Doping Regulations of the International Federation administering my sport, including all amendments and International Standards as mentioned.
3. I acknowledge and agree that the IWGA and the International Federation administering my sport have jurisdiction to impose sanctions as provided for by the WADA Anti-Doping Code, IWGA Anti-Doping Rules and the Anti-Doping Regulations of the International Federation administering my sport.
4. I hereby grant permission to World Games 2005 GmbH and to the IWGA to utilize my appearance, name, voice and likeness in connection with the World Games 2005 in any and all media throughout the world in perpetuity for the purpose of promoting The World Games.
5. I also agree and accept in particular the exclusive competence of the Court of Arbitration for Sport in Lausanne, Switzerland, which will resolve definitely any dispute in accordance with the Code of Sport Related Arbitration, with the applicable law being Swiss Law.
6. Fully respecting your rights to privacy, the Organizing Committee of the World Games 2005 will record your personal Data for the purpose of carrying out the World Games 2005. Your data will be erased afterwards.
