

**RELEASE FROM LIABILITY and CONSENT TO DRUG TEST
FOR ATHLETES COMPETING IN IFBB/EBFF COMPETITIONS**

NOTE: (Please read this release very carefully as when you sign it, you will be giving up important legal rights)

In consideration of the acceptance of my entry form for the 2007 European Men and Mixed Pairs Bodybuilding and Men Classic Bodybuilding Championships – Baku, Azerbaijan, May 04 -07, 2007 I intend to be legally bound for not only myself, but also my heirs, my executors and my administrators.

In signing this release from liability, I waive and release anyone connected with this competition: i.e. IFBB, EBFF; the organizing federation that obtained the sanction for this event, championships sponsors and staff, the contest facilities or any persons associated with the competition from any and all liability, including any results of negligence which may arise from this competition. This agreement also applies injections or injections of other substances into the muscles to enhance body-parts.

Moreover, I agree that any testing method selected by IFBB/EBFF recognized testing officers may be applied to detect the presence of drugs, as listed on the International Olympic Committee (IOC) banned substances list SHALL BE CONCLUSIVE. **Further more, I agree, that any testing method selected by IFBB/EBFF recognized testing offices maybe applied to detect the presence of oil or other substances injected into the muscles to enhance body-parts shall be conclusive.** I agree to co-operate fully with all required IFBB/EBFF sampling and testing procedures. This includes any testing procedures that may be considered necessary prior to or after this event.

Should I fail to pass the drug testing procedures, I agree to forfeit any trophy, award, record or placing which I won during the championships and I also forfeit any previous trophy, award, record or placing should the offence be deemed serious enough, according to IFBB/EBFF rules, to warrant such an action. I understand and agree that if I fail to pass the drug testing process, my name will appear on a published list of suspended members. If it is determined that I have failed the drug test, I agree to waive any claim for which legal relief is available. I also agree to waive any claim which might arise under state, national or international law for defamation, slander, libel, or any other claim for which legal relief is available.

Additionally, I realize that if I do not attend the **2007 European Men and Mixed Pairs Bodybuilding and Men Classic Bodybuilding Championships** for any reason, I will forfeit all fees which cannot be exchanged.

I agree to pay any attorney fees and litigation expenses incurred by any person real or corporate, whom I may sue in an effort to challenge this release from liability.

I understand that my agreement to pay attorney fees and litigation expenses is the SINE QUA NON for acceptance of my entry in these championships. If any provision of this Release from Liability shall be deemed by a court of competent jurisdiction to be invalid, the remainder of this Release from Liability shall remain in full force and effect. I also certify with my signature that this release/agreement cannot be modified orally.
